I am requesting funding for the Horizon City Transit-Oriented Development Phase 1 in fiscal year 2023.

The entity to receive funding for this project is Town of Horizon City, located at 14999 Darrington Road, Horizon City, TX 79928.

The funding would be used for the initial design and environmental study of a Transit-Oriented Development in Horizon City.
